#### Subject of the Disclosure

ICTSI has been declared preferred bidder for the concession of the development, operation and maintenance of the Multi-Purpose Terminal of the Port of Kribi.

#### Background/Description of the Disclosure

On 14th of June 2019, ICTSI has been declared preferred bidder for the concession of the development, operation and maintenance of the Multi-Purpose Terminal of the Port of Kribi by the Port Autonome de Kribi. Parties will now engage in exclusive concession contract negotiations ahead of final contract signature.

The Port of Kribi is located in Cameroon, Central Africa. It is a newly built port with deep draft. The Multipurpose terminal consists of 265m of berth and 10ha of yard.

Kribi port is surrounded by the Kribi Industrial Area, a 262sq.km reserved land destined to accommodate new industrial and logistical developments supporting the Cameroon-Chad-CAR (Central African Republic) Corridor economic growth.

The concession contract has a duration of 25 years until 2045.
